

Minutes of the Meeting of ALLOSTOCK PARISH COUNCIL held on Thursday 26th July 2018 at 7.30pm in the Village Hall.

Prior to the meeting Mr Tim Bird the owner of Three Greyhounds Public House came to discuss traffic concerns. He made the following points:

The dog- leg junction on which his property is situated is dangerous and there have been several accidents and many near misses.

The problem seems to be excessive speed, the junction is in a de-restricted region of the road and therefore it is legal if unwise to go through the junction at 60mph. He would like the 40mph restriction through Lach Dennis extended to meet the 50 mph area at Cranage.

“Welcome to Allostock, please drive carefully” and/or Tourist signs indicating the extra complication of the entrance to his car park might also help. Cllr Still suggested that cutting back the trees on the Shakerley area at the corner of Middlewich Road would also greatly improve the sight lines.

The Council agreed that they have concerns regarding this junction and they will consider how to go about improving the situation. Will need Cllr.Stocks, CWAC Highways Department and the Police to co-operate with this.

Inovyn - Cllrs F.Still and Mrs J Wilson went to meeting. They have started drilling again near Hulme Hall. They have a new contractor A.E.Yates who is putting down the new roads. For reasons of safety they have temporarily closed Footpath 16 for 6 months. There is a new Rights of Way officer Peter Atkinson. This is very close to Hulme Hall. It is also causing extra traffic through Lach Dennls and a new speed limit has been introduced on Common Lane.

Inovyn has a non-disclosure agreement with HS2 so unwilling to give any information.

At a meeting on 3rd July a planning application regarding the Lostock Green Crematorium was turned down by CWAC.

Cllr Still asks that a pile of rubble at junction of Chapel Lane and A50 which has fallen off a lorry be removed. Clerk to try and arrange this.
