

Minutes of the Meeting of ALLOSTOCK PARISH COUNCIL held on Thursday 27th September 2018 at 7.30pm in the Village Hall.

1. **Apologies** were received from Cllr. P. Moseley, Cllr A. Healey and Cllr Mrs A. Owens

2. **Declarations of interest**,

Clerk stated that planning app to be heard tonight was on her land.

3. **Minutes of the last meeting**-accepted. Proposed Cllr .J.Roberts Seconded Cllr.Mrs P.Adlington

4. **Matters arising**

- Discussed letter to be sent to Police, Highways and Cllr Stocks regarding speed limit at junction by Three Greyhounds Public House. (Landlord of Three Greyhounds to receive a copy.)
- PCSO Hambleton to be asked if he would attend a Parish Council meeting
- Clerk has spoken to resident who owns hedge where Boots Green Noticeboard is situated. The Noticeboard is redundant and will be removed and if necessary the hedge will be repaired.
- Lach Dennis Crematorium has planning problems.

5. **Parish Field.**

- Tables which are very heavy need moving, they are too close to parking area. Letter received from a member of Evergreens Club saying she had damaged her car by driving into table. Cllr Mrs Wilson will ask Cllr.Moseley if he can arrange to have them moved close to the hedge. If they are to stay there they would require to be placed on concrete flags or they will rot.
- Dog Mess on field is according to some members of the Village Hall committee a major problem. The feeling of the Councillors was that if they were to arrange to ban dogs from the field it would cause hardship for the majority of local dog owners who do clean up after their pets. Bin and bags are provided but some people are irresponsible.To look into providing CCTV as a deterrent.
- Grasscrete-difficult to source and too expensive for Parish Council,

Social Committee still needs to decide what they are doing about roof, there is money available from Storengy for insulation but they will require up to date quotes. Next SC meeting 18th October.

Defibrillator, after discussion it was felt that the best place to site one would be on the Village Green. Clerk will inquire if this is feasible and costs.
