**4. Matters arising.**

Footpaths 15 and 16 still closed for Inovyn brine extraction. Cllr. Mrs Owens notes the Bridle path through Chapel House Farm is still closed. Clerk has had no response from Rights of Way officer, she will contact Cllr. Mark Stocks to see if he can help. Closure signs in place on Hulme Hall Lane and by Hulme Mill.

Bartletts Tree surgeons have inspected trees on Parish Field with Cllr.Still. No action required at the moment but they will look again before caravan season.

Cheshire railings have been installed at New Platt Lane/A50 junction. Cllr Mrs Adlington was unable to access Liaison Meeting but she has circulated the minutes. The tree that was felled opposite Sibelco site entrance was rotten and they say they have no plans to fell any more trees. There was a query about HGV'S using Northwich Road but it was felt that this is allowed. Cllr Mrs Adlington will check. Cllr Mrs Owens was concerned about the area of land between Cheshire railings and old fence but this is private land and as such will be maintained by the landowner.

The tree opposite Boundary Park which Cllrs. and residents were concerned about has been felled.

Boots Green Sign, still waiting for further information regarding repairs from local resident who is concerned about the appearance of any repair.
